

# Galaxy Tablet Lease Agreement

**Now, THEREFORE, in** consideration of the mutual covenants and promises hereinafter set forth, the parties hereto agree as follows:

**1. LEASE**

**Lessor** hereby leases to **Lessee**, and therefore, **Lessee** hereby leases from the **Lessor**, the following described equipment (the "Equipment"):

**2. RENTAL and Deposit**

The total rental fee shall be **\$40.00 bi-weekly payroll deducted.**

**\$150.00 deposit will be held back from your first paycheck**

**3. TITLE TO GALAXY TABLETS**

Title to the Galaxy Tablet that is the subject matter of this lease shall be and will remain with Lessor at all times.

**4. MAINTENANCE OF MACHINES**

Lessor guarantees to maintain insurance coverage and agrees to keep the computer in good working condition under and through standard agreed upon usage and age of Galaxy during the term of this lease.

## 5. LIABILITY

Lessee will be responsible for the locking-up and security of the Galaxy tablet. Lessee shall be liable for deductible of \$150 in the event of property damage, destruction, misuse, neglect, or theft (must produce police report).

## 6. MAINTENANCE

Lessee shall at all times keep the Galaxy tablet clean, safe, and in good condition.

## 7. Miscellaneous

- The above-mentioned Galaxy shall be used by Lessee at their place of business for BUSINESS PURPOSES ONLY.
- NO data downloads, NO music downloads and NO text messages.
- Each Galaxy comes **with 2GB data usage; Lessee agrees to pay \$10 for each additional GB of usage** should overage occur, which will be payroll deducted. (You can check your usage by clicking on the “my Verizon mobile” icon)
- Should the contract be termed by either party and tablet, charger and hard case is returned in good condition, **\$150 Deposit** will be pro-rated by the condition of the unit.
- Missing charger is \$25.00
- Missing hard cover is \$70.00
- **The Galaxy tablet can be returned:**
  - By delivering to the Columbia or McCormick IT Staff
  - Put in United States Post Office “if it fits, it ships” package and send to:

We will credit back the postage up to \$11.00 on your last check

- If you resign and/or terminated and you do not return the rental tablet to Caotti within 7 days from termination,
  - We will charge you \$350 out of your reserve.
  - If you do not have enough in your reserve, we will proceed with criminal charges of property theft.

## 8. APPLICABLE LAW

This lease shall be governed by and construed under the laws of the State of Georgia.

## 9. LEASE AS ENTIRE AGREEMENT; SEVERABILITY

This lease embodies the entire agreement between the parties. It may not be modified or terminated except as provided herein or by other written agreement between the parties. If any provision herein is

invalid, it shall be considered deleted from this lease, and shall not invalidate the remaining provision of this lease.

**10. MANNER OF GIVING NOTICE**

Any notice to be given under this lease shall be mailed to the party to be notified at the address set forth herein by registered or certified mail with postage prepaid, and shall be deemed given when so mailed.
